**First Vice President – Doreen Berson**

**New Jersey Lighthouse Managers Liaison**

Doreen reported that the Challenge shirts were ordered and should be available at certain lighthouses by the end of July.

The NJLHS will be designing and financing the souvenirs for 2014. (This is the 15<sup>th</sup> Anniversary of the Challenge.) The idea the managers had is a puzzle which Brett is working on. Brett has an idea for a 3 sided puzzle. One side will be a puzzle featuring a Paul Bradley drawing of Sandy Hook, another would be the NJLHS logo and the third would be the Greg DiNapoli drawing of all the lights of NJ. Another idea was a Lego type piece given at each location and when put together it would build Sandy Hook light. Brett feels the challenge needs to be "juiced up again". Souvenirs bring the people out and keep them returning.

Members at the meeting expressed concern that the puzzle should be something with a backing so the if the visitor did not complete the Challenge, there was still an underlying photo. We also have many copies of past souvenirs which will be sold at Finns Point. Matt Riley mentioned that many people who saw the miniatures of the lens and a map with the mini lights shown at the Sandy Hook Anniversary were very impressed and said that would be another good idea for the souvenir.

Rack cards for the Challenge are available. The design on the rack card is the same as will be on the Challenge shirt.

Volunteers will be needed and will be signing up at the September meeting. Rick Hodgeman expressed concern with the input of NJLHS at the Managers meetings. He was assured that the NJLHS would be in charge of the souvenirs and their being given away at the locations. All volunteers that day will be given a complete set of souvenir pieces along with a t-shirt (possibly Challenge shirt or other shirt).

Another idea was to have local school students draw pictures of the lights and display them during the Challenge weekend. The Challenge weekend in October is the largest profit and support weekend for the lights all year.

- **Sandy Hook Anniversary – Jim Cope**

Jim reported that there were over 300 visitors who toured the light during the June 14<sup>th</sup> celebration. Many government dignitaries were there along with encampments and corps. People were spread out all over that day

and no actual final number as tallied. The Highlands Post Office was there to post mark in honor of the occasion. We have caches' available for purchase from that day.

Doreen gave a big thanks to all who attended, especially Lauren and Matt for manning the NJLHS table.

- **Sandy Hook Funds – Brett Franks**

Brett reported that the society had set aside \$15,000.00 to use for the Sandy Hook Anniversary. We used \$1,700.00 for transportation, which is what Sandy Hook requested from us. The transportation was for a trolley to take guests from parking areas to the lighthouse. We still have approximately 13,000.00 left in the fund and would like to do something meaningful with it. One idea is to make a documentary film honoring Sandy Hook, its 250<sup>th</sup> Anniversary and the 350<sup>th</sup> Anniversary of New Jersey. Karen found someone who has experience making films and is interested in this project. His name and information was given to Brett. Another idea is to publish a book through a historical book company which contacted us on Sandy Hook to be part of their series. Brett will look into this further.
